## **LICENSE AGREEMENT**

This License Agreement (Agreement) is made and entered into between **POLK** County (Licensor) and **THE ARTHUR H. ROBINSON MAP LIBRARY – UW MADISON** (Licensee). Polk County, WI GIS data, which are subject of this Agreement, is hereinafter referred to as “the Data.” The parties agree to the following:

1. Licensor hereby grants to the Licensee a non-exclusive, non-transferable license to use the Data in accordance with the provisions stated in this Agreement.
2. Licensor exclusively owns the Data that is the subject of this Agreement and has authority and legal right to grant Licensee a license to use the Data provided in this Agreement.
3. Licensee shall be provided the Data without a fee provided that the Data is used for educational purposes only.
4. Licensor reserves the right to gain GIS data from Licensee at no charge, which was created using our Data.
5. Licensee may combine the Data with different data to create new and original electronic or hardcopy products which Licensee can use, however, this data may not be duplicated or reproduced for sale, licensing or distribution in any manner without written consent of Licensor. Licensee may create a reasonable number of copies to be used internally. Licensee shall keep a record of the location of each copy.
6. Consultants of Licensee not named in this agreement shall not use Data unless the Consultants obtain written consent from the Licensor’s Land Information Director.
7. LICENSOR IS FURNISHING THE DATA ON AN “AS IS” BASIS, WITHOUT ANY SUPPORT WHATSOEVER, AND WITHOUT REPRESENTATION OR WARRENTY, INCLUDING BUT NOT IN ANY MANNER LIMITED TO, FITNESS, MERCHANTABILITY OR THE ACCURACY AND COMPLETENESS OF THE DATA BASE.
8. The DATA BASE is neither a legally recorded map nor a survey and is not intended to be used as one. The Data Base is a compilation of records as they appear in Licensor’s offices affecting the area shown. It is to be used for reference purposes only. No representation is made that features presented, accurately reflect true location. Licensor assumes no liability for any errors or omissions to the Data described herein. If discrepancies are found, Licensee may contact Licensor’s GIS Division under the Land Information Department.
9. Licensor’s sole liability and Licensee’s exclusive remedy for any substantial defect which impairs the use of the Data for the purpose stated herein shall be the right to terminate this Agreement.

11. If Licensee fails to comply with the terms and conditions of this License Agreement, it may be terminated by Licensor by means of a written notice. Upon termination of this Agreement, the Data shall be returned to the Licensor within 5-10 days and any other copies destroyed.
12. This Agreement shall be governed by and construed in accordance with the substantive and procedural laws of the State of Wisconsin.
